What data do we collect?

Eile Mental Teo. collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

How do we collect your data?

You directly provide Eile Mental Teo. with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

Eile Mental Teo. may also receive your data indirectly from the following sources:

- Other associated companies or service providers

How will we use your data?

Eile Mental Teo. collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.

When Eile Mental Teo. processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

How do we store your data?

Eile Mental Teo. securely stores your data on site.

Eile Mental Teo. will keep your contact details for 6 years. Once this time period has expired, we will delete your data.

Marketing

Eile Mental Teo. would like to send you information about products and services of ours that we think you might like.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop Eile Mental Teo. from contacting you for marketing purposes.

If you no longer wish to be contacted for marketing purposes, please contact us.

What are your data protection rights?

Eile Mental Teo. would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

The right to access – You have the right to request Eile Mental Teo. for copies of your personal data. We may charge you a small fee for this service.

The right to rectification – You have the right to request that Eile Mental Teo. correct any information you believe is inaccurate. You also have the right to request Eile Mental Teo. to complete the information you believe is incomplete.

The right to erasure – You have the right to request that Eile Mental Teo. erase your personal data, under certain conditions.

The right to restrict processing – You have the right to request that Eile Mental Teo. restrict the processing of your personal data, under certain conditions.

The right to object to processing – You have the right to object to Eile Mental Teo.'s processing of your personal data, under certain conditions.

The right to data portability – You have the right to request that Eile Mental Teo. transfer the data that we have collected to another organization, or directly to you, under certain conditions.
